



## Annual Report 2024-25

Yet another year where we saw ourselves consolidating our seamless functioning as well as seeing many new developments on infrastructure front as well as enhancing the scope of our functioning to reach even more needy beneficiaries.



## Annual General Meeting 2024

## Meetings

During the year under reference the Executive Committee and the Governing Council members met periodically at various instances to discuss and review various activities and decide on the way forward.

## Membership

Members are the lifeline of our Foundation. We have currently 5 categories of members – Patron Member, Corporate Member, Benefactor Society Member, Ordinary Life Member and Sustaining Member.

Patron/ Corporate Patron paying Rs. 5 lakhs, Corporate Member/Benefactor paying Rs. 1 lakh and Life Member paying Rs. 10,000 as donation to the Foundation while enrolling as members. Benefactor Society Membership is given when a member commits to pay either Rs. 1 lakh every year or Rs. 10,000/- every month as a confirmed donation, he will then be called as a Benefactor Society Member and his/her name will be displayed at the Cancure Centre in a special board and with an option to dedicate the membership in memory/ commemoration of a person(s) or a brand. In addition to these regular members of the Foundation with full voting rights, we also have the Sustaining Member who makes

a commitment to pay a minimum monthly contribution of Rs. 500 or an annual contribution of Rs. 6,000 or more. Though they are part of the Foundation and are kept in touch regarding the activities and developments, they do not have voting rights.

We continued to follow strict guidelines of ensuring unanimous acceptability among existing members before inviting probable individuals/corporates to become members of the foundation, and based on a no-objection from all existing members only all these members were added. This has ensured that all our members are of impeccable stature and standing in the society and are the real assets of our Foundation. Currently we have 331 members including newly added 3 life members and 5 benefactor society members since we held our last AGM. We also have 89 Sustaining Members as on date.

## Activities at the Foundation

### Rotary Cancure Lourdes Dialysis Centre

Since the launch of operations in February 2021, our Dialysis Centre has successfully completed over 13,200 free dialysis sessions. With 2 shifts of dialysis processes starting at 7 am on all 6 days of the week, we are presently catering to 35 regular patients. Of these only 4 patients are being charged a nominal fee of Rs. 350/- per session, while the rest are provided totally free dialysis. Although a subsidized registration fee of Rs. 350/- per dialysis is permitted as per the agreement with Rotary, most of our patients are under severe financial strain, and hence we continue to offer almost all sessions free of charge.

During the financial year 2024-25, we paid Rs. 35.4 lakhs to Lourdes Hospital towards their medical and technical support. With the dialysis machines now past their 3-year warranty period, we are making payment of Rs. 1.5



lakhs towards their Annual Maintenance Contract (AMC) from this year. We are grateful to M/s. Fresenius Medical Care, the manufacturers of the dialysis machines, for offering a special AMC rate based on our request. As per our agreement with Lourdes Hospital, Cancure pays Rs. 825/- per dialysis session, and nearly Rs. 1.10 crores have been paid till date towards their continued support. The centre continues to operate from Monday to Saturday, strictly adhering to all safety protocols, and without break even on national or festival holidays. It is noteworthy to mention that operations have remained completely uninterrupted since inception. The total expenditure incurred for dialysis services alone during 2024-25 is Rs. 56 lakhs. The centre is now operating at full capacity.



**Additional machines donated by Rotary Cochin Central:** We are happy to report that 5 new dialysis machines and all the related equipments were donated by the Rotary Club of Cochin Central, as part of a Rotary Foundation project. A soft launch of the new dialysis room was held in the presence of Rotary Club representatives and a few of our Governing Council members, to do the testing and confirm the seamless functioning of the additional facility. Everything is in order now and we are poised to enhance the daily numbers from 15-16 dialyses now to 22-25 dialyses per day. This also means a significant increase in our operational expenses by almost 60%, and we need to ensure that we mobilise these extra funds by finding new donors.

**Patient Support:** During the year, we extended support to a long-time dialysis patient at our Centre, who had to go undergo a serious brain surgery at Lourdes Hospital. She was in no position to fund her additional treatment and was seeking support from her neighbours and friends. Knowing her plight Cancure intervened as a special case, and the huge gap in funding was covered by the generous contributions of two of our Governing Council members. It was indeed a blessing to be able to support her in this critical phase as she underwent the surgery successfully and is now back at our centre again for regular dialysis.

## Cancure Santhwanakendram - Palliative Care Centre

The Palliative Care Centre which started in March 2021 with just 3 inmates is currently functioning with 35 inmates – all of them bedridden or terminally ill patients referred by the General Hospital, Ernakulam. During the year under report, 16 patients expired at our centre and 18 patients got better with our proper care and were discharged. Cancure directly pays or reimburses the day-to-day operational expenses including food, electricity, water, and maintenance on a monthly basis. During the year of reporting, we paid over Rs. 21 lakhs towards food expenses and another Rs. 10 lakhs for other expenses towards palliative care.



The palliative care activities are being effectively carried out by the team led by Mr. K. J. Peter and his Jeremiah's Home & Bertoni Palliative Care, a charitable trust that has entered into an MoU with Cancure. The support team consists of 15 well-trained staff members who provide holistic care to the inmates and are available 24X7 at the centre. Doctors from the General Hospital conduct rounds to check on the patients' conditions, and our duty doctor at the dialysis centre also monitors the palliative care inmates when needed.

Cancure Santhwanakendram is now considered a role model for a well-run palliative care centre in this part of the world.




## Special Days commemoration at Santhwanakendram

Patron Member Mr. Salil Gupta, Ms. Smita Gupta, and their children Ms. Sana and Mr. Siddharth Gupta also supported us on their birthdays. Our Vice President & Benefactor Society Member Dr. C. M.



Radhakrishnan celebrated his birthday with breakfast and cake along with our inmates and team, and his family generously supported the day's food and dialysis expenses on many days. On the second death anniversary of his brother and our Founder Member Dr. C. M. Suchindran, Dr. Radhakrishnan's family also donated 100 bedsheets and pillows for the inmates. Vice President Shri. S. Rajmohan Nair handed over his annual contribution of ₹1 lakh on the solemn occasion of his father's death anniversary. Ms. Susie Paul too supported the dialysis expenses on her birthday. Golden Jubilee anniversary wishes were extended to Dr. C. M. Radhakrishnan and Smt. Usha by the Cancure family by offering a cake at their house, while they supported our expenses on that day. The MSP Group sponsored a day's food in memory of their founder Shri. Radhakrishnan, who played a vital role in conceiving the Rotary Dialysis Centre project. We were also honoured to welcome renowned singer Shri. Cochin Mansoor, whose soulful performance



brought joy to all present. The TCS Maitri group visited the centre, spent time with patients, sponsored food for the day, and gifted uniforms to all inmates. One of our non-member and regular supporter Mr. Renjith Jose commemorated his father's anniversary by supporting our expenses. On such commemorative days, a photo or dedication is displayed on the LED screen at Santhwanakendram, followed by a collective prayer and a shared meal with the inmates and staff. We also display the photos of the departed souls of the relatives of our Benefactor Society Members, in whose memory they are contributing substantially year after year to support our operations, and pray for them. We sincerely thank all those who thought of Santhwanakendram on their special days and supported our cause through their generosity and presence.



## **'Rotary For Her Cure: Mathruraksha' – project supporting Breast Cancer patients**

The Rotary Mathruraksha Project, launched in February 2022 by Rotary Club of Kochi United in partnership with AIMS, continues to provide timely surgical and follow-up care for underprivileged breast cancer patients. Under the scheme, Rotary supports treatment expenses up to ₹1,00,000 per patient, with any additional costs if any, covered by AIMS. As of now, 94 patients have been referred through AIMS, and 72 patients have been formally included under the project.

Cancure functions as the coordinating agency between Rotary District, Rotary Kochi United, and AIMS. Our team conducts detailed socio-economic verifications, household visits, and documentation to identify genuine beneficiaries, regardless of their location. Each approved patient receives full coverage for breast surgery, chemotherapy, and radiotherapy. We gratefully acknowledge the ongoing commitment and expertise of our Medical Advisor and Head of Department at AIMS Kochi, Dr. D. K. Vijayakumar, whose role has been instrumental in the success of this initiative.



## Mobile Mammography Unit and 'Rotary For Her Care' Camps



Our Mobile Mammography project has faced serious technical challenges during the year. The machine's cooling system was repaired and a test screening was done successfully during the year at AIMS premises. This trial camp was conducted on 11th January 2025, screening 4 patients. However to make it into a seamless operational unit for remote camps like earlier days, many other related repairs were needed to the power supply and other units. Meanwhile the vehicle was repaired and refurbished and the mandatory testing and re-registration at the RTO were done during the year.

Unfortunately, AIMS officials are not fully satisfied with the project now, as the technology of our project seems to be outdated and they wish to go with better equipments with latest technology for better screening and results. AIMS is in the process of upgrading this project with a newer machine and then exploring the possibility of restarting the project the way we had done it in the past. Rotary approval is being sought by AIMS to do the same. Modalities need to be worked out on this, as we have already crossed 7 years since the existing project was initiated.

## Repair & Maintenance works executed

During the year, several essential repair and maintenance activities were carried out at both our centres. At the Cancure Lourdes Dialysis Centre (CLDC), regular upkeep included replacement of dialysis filters and annual maintenance of the dialysis machines, ensuring uninterrupted and safe patient care. The kitchen area and the exterior open space were covered using materials recovered from the old house we purchased alongwith the new land and this area is now being utilised in a better manner. These works were completed efficiently and we extend our sincere thanks to the Governing Council members and Joint Secretaries Mr. Vijayan and Mr. Saji Chandran who oversaw and guided these activities, ensuring quality work at optimal cost without affecting day-to-day operations. Oxygen piping for patients also was relaid during the additional machine installation by the Rotary Cochin Central project and now the cylinders are installed in a more convenient manner for easy access and refilling.

## Tax exemption from Government of Kerala

We continue to benefit from the tax exemption granted by the Government of Kerala, which covers both our building and the annual taxes on our vehicles. Additionally, we receive subsidized electricity tariffs through the support of KSEB, which has been a significant relief given the high-power consumption of our medical equipment. Efforts are also underway to secure a similar concession for our water charges, which form a considerable part of our operating expenses. We sincerely thank our Joint Secretary, Mr. Vijayan, for his timely and effective involvement in facilitating these approvals



## Bylaws Amendment

Our Memorandum of Association and Rules & Regulations documents as approved by Registrar of Societies and Income Tax authorities were updated extensively as approved at the last AGM and the subsequent Governing Council meetings during the year. Our Advisor CA Sathyaranayanan and other GC members lead by Treasurer CA Mathew Joseph and Sr. Vice President Mr. K. V. Narayanan Kutty reviewed each points thoroughly and amended the documents to suit our current operations and needs. These were then filed for approval at IT department and thereafter at the Registrar of Societies. The approvals were received promptly during the year and the new Bylaws document is now available and sufficient copies are kept for ready reference here at the AGM.



## Donations from good hearts – Our lifeline to go on with our good work

We continue to receive support from our members & many well-wishers on a regular basis. Monthly/ annual donations from our Benefactor Society members remain our main source of funding and some of the names that cannot be missed here are our dear members Mr. Salil Gupta, Mr. K. V. Narayanan Kutty, Mr. Gokul Das, Dr. C. M. Radhakrishnan, Ms. Deepa Saji, Mr. Dinesh Thampi, Dr. Binnu Joseph, Mr. Mathew Joseph, Mr. Vinu C. Verghese, Mr Bibu Punnooran, Mr. Prasad K. **Zwagg Fitness Centre** organized a 'Pink Party Dancethon' commemorating Breast Cancer Awareness month and mobilized nearly Rs. 2 lakhs to support our operations. Ms. Poornima Viswanathan founder of Zwagg has been so supportive to have Cancure as their charity partner and handed over the cheques to us.

**Ernakulam District Panchayat** has a scheme providing Rs.1,000/- per week for dialysis of the economically backward patients under the directions of the District Medical Office, Ernakulam. Cancure has been receiving this amount during the year of 2024-25 also for the patients who were selected for the scheme. An amount of Rs.16,06,050/- was received as grant from them during the last year. This year too Panchayat will have the scheme running to help our patients.

### New Dialysis Room inauguration



A public event is being planned in the coming days to mark the ceremonial announcement of the new addition of 5 dialysis machines and equipments to our centre. This is mandatory for the Rotary project and is also aimed at publicizing our good work to inspire more donors to support us.

### 'Cancure Can Care' Centre – Project Expansion

We are at the cusp of launching the construction of our new building to mark the expansion of our Santhwanakendram – a milestone project that is set to transform our Foundation into one of the most unique and impactful institutions in its domain. Once completed, the new building will house 100 beds for palliative care and 25 beds for dialysis patients, making it one of the largest centres in this segment. The project committee led by our Senior Vice President Mr. K. V. Narayanan Kutty had formed multiple subcommittees to accelerate the launch. The Construction Committee, under the leadership of Mr. J. Paul Raj, is actively pursuing the necessary permits. We express our heartfelt gratitude to our Vice President Mr. Binesh Sukumar, who has created a beautiful and futuristic design for the new building through his firm – entirely as a pro bono service. We also recall with gratitude the

time when every member came forward to contribute towards the land purchase without reaching out to external donors. Now, as we prepare to raise funds for this new project, the Fundraising Committee headed by Past President Mr. Thomas Joseph is working to secure support from individuals and corporate donors, offering them opportunities to fully or partially sponsor the three floors of the building. While Mr. Salil Gupta and Ms. Smitha Gupta, Benefactor Society Members and founding members of our Foundation who had sponsored one floor of the current Santhwanakendram, have committed to sponsor one floor of the new building as well, Mr. Sumit Goyal and Ms. Anita Goyal have also generously committed to sponsor one of the other floors. The floor that will house the dialysis centre will be named in memory of Late Smt. Mary

Jacob, wife of our founding Life Member Mr. L.M. Jacob. The construction and furnishing of this floor will be funded from the sale of land earlier donated by Mr. Jacob — a property with emotional significance, as it was purchased by Mr. and Ms. Jacob in their early years of marriage, and gifted as a token of gratitude for the blessings they received from the Lord. We salute this touching gesture.

We solicit more such noble hearts to come forward and be a part of this mission. The opportunities for partnership

## **Cancure Nursing Aides Institute**

Major Susie Paul was assigned the role of the Chairperson of the 'Cancure Nursing Aides Institute' Committee, to establish the much-awaited training institute for caregivers and nursing assistants. This was not taken up during the year as the space earmarked for the Institute was used up for the additional dialysis beds created using the Rotary project. The Institute project will be taken up again once our new building is ready with enough space.

## **Cancure Funeral Home**

The Cancure Funeral Home project, chaired by Vice President Mr. S. Rajmohan Nair, is a pioneering initiative that, once realised, will likely be the first of its kind in the country. Designed as a holistic facility rather than just a crematorium, it will handle every aspect of the final journey from transporting the mortal remains to providing an elegant space for last respects, assisting

with final rituals, and transferring to the cremation or burial site irrespective of caste or creed. The committee met twice during the year and the project has not gained much traction and the initiative still remains in the planning and development stage, and expecting a visible progress towards its realisation.

## **Eligibility for raising CSR Funds as recognized by MCA**

Cancure Foundation is registered with Ministry of Corporate affairs vide Registration Number CSR00002427 and duly eligible to receive CSR funds from corporate houses.

## **Registration with CBDT for 80G and other benefits**

All statutory compliances under section 12AB and section 10(23C) of the IT Act are maintained vide Unique Registration No. (URN) AABTC7227JF20216 valid from AY 2021-22 to 2026-27 (5 years) and thus eligible for all the tax benefits of a bonafide charitable organization.

## **Auditors**

M/s. Subi Joy & Associates was appointed as auditors for the period of report and they have done a meticulous work in auditing our accounts and presenting the same before our members here. We place on record our gratitude to our auditors as well as to the entire staff members of our Treasurer Mr. Mathew Joseph for their inputs and efforts in doing a complete and comprehensive task with all the statutory compliances and reporting being taken care of.


